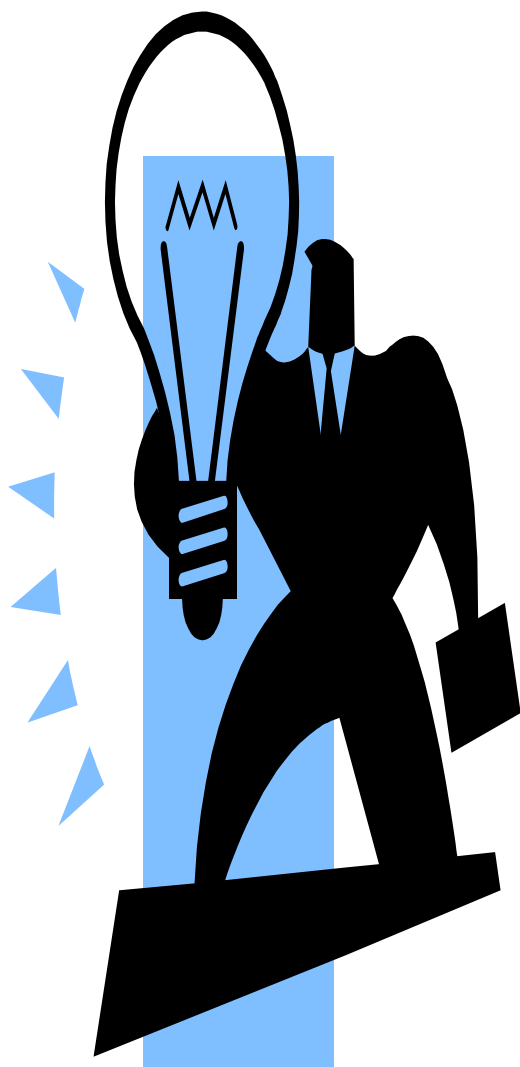

Make note of the **Referral Number** on your Websites Unwoven flyer...

You will sign up by establishing your MyLocalPro.com profile ..

Choose either the Local Business Directory or Nation Directory, and then follow the sign up steps.

When prompted, enter the Referral Number

If you choose Local Business Directory, then enter Special Offer Code LB90001 to trigger \$12.00 fee.

If you choose the Nation Directory, then select the Gold membership

Complete sign up and verification steps.

Your registration will automatically initiate your OMGitssoeasy featured listing and the generation of your Websites Unwoven flyer. Your hard copy and shortened link will be forwarded to you for circulation.

TERMS & CONDITIONS

By choosing to participate in the Websites Unwoven opportunity, you are inherently acknowledging that you have read and are accepting these Terms and Conditions.

By establishing either a Local Business Listing or a Nation membership at MyLocalpro.com, you are contracting with MyLocalPro.com, not Websites Unwoven, and must comply with the Terms of Use outlined on that site.

A summary of the more critical conditions are spotlighted at this time for your convenience. Unless otherwise stated, the Terms of Use stated by MyLocalPro.com supersedes any other terms or conditions.

Participation Eligibility

1. All participants must be at least 18 years of age.
2. All participants must be US citizens with US addresses.
3. The Websites Unwoven opportunity must be voided where prohibited by law.

Operating as an Independent Representative

As a participant in all of our referral and affiliate programs, you inherently agree to operate as an Independent Representative ("IR"). As an IR, you will be treated as independent contractors for all federal or state tax purposes. As such, Independent Representatives will not be treated as employees, franchisees, joint ventures, partners, employees, or agents with respect to the Internal Revenue Code, Social Security Act, Federal Unemployment Act, state unemployment acts, or any other federal, state, or local statute, ordinance, rule, or regulation. All Independent

Representatives shall comply with all federal and state statutes and regulations and local ordinances and regulations concerning the operation of their businesses.

All Independent Representatives are responsible for their own managerial decisions and expenditures, including all estimated income and self-employment taxes. At the end of each calendar year, MyLocalPro.com will issue an IRS Form 1099-MISC for non-employee compensation for Independent Representatives as required by law. The inability of Members to provide all information required for issuance of IRS Form 1099 will result in the suspension of payments until information is obtained. If such information is not obtained within six months from the initial request, withheld balances and any subsequent balances may be forfeited.

As an Independent Representative, you may communicate your affiliation with Websites Unwoven, but may never represent yourself, either directly or indirectly, as an employee. All promotional material shall state that you are an Independent Rep of Websites Unwoven.

Violation of the Independent Representative requirements or any other term of this Agreement shall result in the termination of your membership and forfeiture of any compensation accrued and due to you at the time of infraction or any time thereafter.

Independent Representatives may terminate their Independent Representative activity by simply ceasing referral efforts. or status (separate from Membership status) at any time upon written notice. Websites Unwoven, via MyLocalpro.com may suspend or terminate an Independent Representative for cause upon written notice.

Promotional Material & Advertising

Participants will be provided with a Websites Unwoven referral code and a template of approved text available for participants to use in the promotion of and referral to the site. Participants will receive a pdf file of their personalized flyer and will be issued a long link and short link for promotional purposes.

Websites Unwoven will regularly forward participants updated approved script and narrative that can be used for promotional purposes

Participants are strictly prohibited from representing themselves as anything or anyone other than a participant and MyLocalPro.com local business client or Nation Member.

Participants are restricted from altering the text and promotional templates. You may submit proposed material or text for approval at websitesunwoven@yahoo.com

SPAM is prohibited and will result in a termination of this arrangement.

Payment Communication & Issuance

All payment related matters will be coordinated and issued through MyLocalPro.com.

Nation members will receive an intra-site message each time their efforts, or the efforts of any of his or her team members, results in a credit to your account. Local Business participants will receive the same message via their designated email.

Payments for compensation will be issued bi-monthly. There is a minimum accrued balance requirement of \$25.00; otherwise, your balance will roll forward until the minimum pay-out is achieved for the next scheduled payment date. All payments will be issued in the form of a check, made payable only to the name provided in the sign up and issued only to the sign up address. In the case of a business, payment will be issued in the name of the business.

Payment will be paused if the accrued compensation requires additional personal information, including a social security number for the issuance of IRS Form 1099-MISC.
